

Introduction to Long Term Care

For all of us, there is a chance that at some time we may become unable to take care of our own physical needs, and become a potentially devastating burden on our family and financial resources. Long Term Care is insurance to provide funds in this scenario and reduce that risk of financial stress. Essentially, you are placed into a pool with like-minded people who recognize the possibility of needing some type of care, and are willing to contribute a manageable premium on a regular basis so that money will be available to you if you need it.

The simple fact is that none of us can predict the future. We don't know whether we will be disabled, how long the disability will last, or how soon it will happen. It is only responsible to have some plan for what to do if you cannot take care of yourself. Do you have family who will be capable and willing to take care of you for a long period of time?

The most obvious factor in evaluating insurance is cost. Beyond ensuring that you can reasonably afford the premiums, there are several basic aspects of long-term that enable you to tailor the policy to your needs:

Maximum Daily Benefit How much the policy will pay per day of disability. Naturally, the higher the benefit, the higher the premium. Benefits are often provided based on the expected cost of a day of care in a nursing home, which currently would be between \$200 and \$300 per day.

Elimination Period How long you must be disabled before receiving benefits. You might think of this as a deductible, where you expect that you can afford to pay for the first 90 days or six months of care before receiving policy benefits. A longer elimination period will reduce the premium.

Benefit Period How long you may receive benefits. This may be anywhere from a year to lifetime.

Inflation adjustment Allows the benefit to increase as overall costs of care increase. This can be arranged so that premiums increase as well, but may also be set up so that your premium is fixed.

Our Financial Advisor has found that there are several opportunities for discounted rates on long-term care insurance that can be made available to an association like ours. We would also like to gauge the interest among our members, especially those who do not already have a long-term care plan.
